

# Rockwood Low Volatility Bond

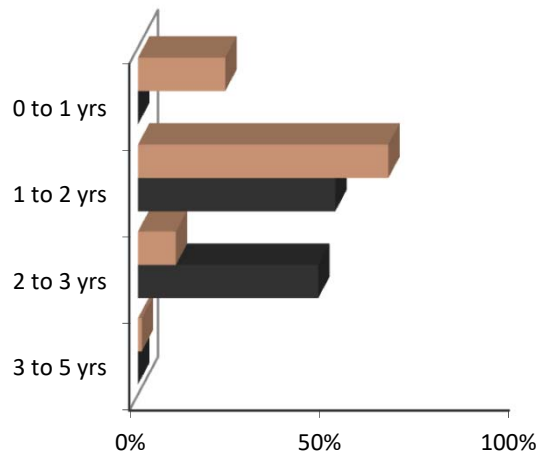

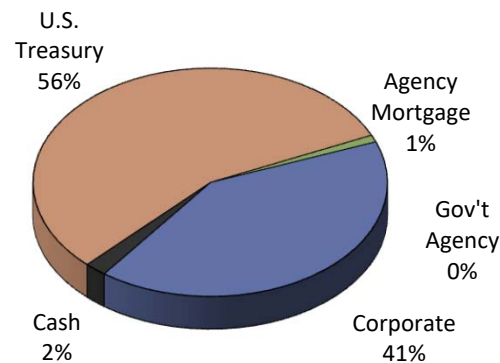
